Conference Proceedings

Inaugural Session:

Moderator: Mr. Asim Zafar Secretariat Coordinator CBID Network

The inaugural session was initiated by Mr. Asim Zafar (*Secretariat Coordinator CBID Network*).

Conference began with the recitation of Holy Quran. Later, Mr. Asim Zafar invited Dr. Muhammad Shahnawaz Munammi (National Coordinator) who delivered the welcome speech. He welcomed all participants and Organizations in 6th National conference. He was hopeful about what has been done and what has to be achieved yet. He concluded that the next session will be good and full of new information.



After introducing the supporters who made the conference a wonderful success, Mr. Asim Zafar invited Dr. Sheikh Tanveer Ahmed (Chief Executive HANDS) for formally initiating the proceedings of the conference. He was delighted to be a part of the historic conference designed to advocate rights of Person with Disabilities and pay a tribute to the efforts of all those committed to this pivotal cause. He emphasized that we have a challenge of SDGs 2030 ahead of us for which none of the targets for development of Person with Disabilities has yet been achieved by Pakistan. He stressed on the need to review these targets with new energy

and take initiatives to achieve those targets. Furthermore, He said that we want to see all stockholders and government on this platform while taking this caravan SDG 2030s goals can be achieved.

In the end He paid gratitude to the all participants, organizers and honorable guests.

Next speaker was Ms. Farah Naz (Country Representative CBM Pakistan) congratulated CBID network and HANDS for committedly arranging this (Person with



Disabilities development issues) conference. She added that it is a huge agenda and we need more efforts to achieve this. She Talked about SDGs saying that this is the 1st time in terms of the global commitments that seven (7) SDGs are explicitly for Person with Disabilities and other six also referred to the persons who are in vulnerable situations, 7 targets are universal and 2 referred to nondiscrimination. She said that we severely lack commitment to achieve these goals. Overall, this agenda gives us a more focus oriented approach about what the

government contribute and what we contribute or can contribute to them.

Mr. Andy Marrie (Representative DFID Pakistan) was next to speak, He came from Scotland. He was delighted to pay thanks to CBID network and Pakistan which gave him the opportunity to speak to a dynamic and differently abled audience. He added that he was proud to advocate the rights of Person with Disabilities for they are greatly discriminated against. He added that He has attended many conferences about PWDs development. After attending these conferences he felt that world is being preceded by National disability. In Pakistan, voice about this agenda is entirely safe.



He added that his superiors are very passionate about this agenda and they are going to launch a show on inclusion of disability. And for this they are going to focus on much more inclusive programs that will meet their desired outcomes. These programs raise awareness

about the critical situation of Person with Disabilities. In the end, He paid good wishes for the achievements of their targets.

The next speaker Ms. Munaza Gillani (Country Representative SightSavers Pakistan) on this platform, we can see people from all provinces of Pakistan. Especially disabled people who are role models in their fields and impressing the non-disabled community. She narrated how SightSavers have been contributing for



inclusive education and health. Through eye services, Sightsavers is going to collect data about Person with Disabilities in four districts of Pakistan. Every patient will be asked about Washington Gross. Through this data we will be able to find out about how much Person with Disabilities are availing these services. She said that we make accessible hospitals for different kind of disabilities.

On the arrival of Chief Guest Mr. Sheharyar Afridi (Federal Minister of Interior Government of Pakistan) welcomed by Mr. Asim Zafar and all Organizers, Mr. Shah Nawaz Munnami presented the efforts of CBID network in front of Federal Minister of Interior, Mr. Sheharyar Afridi and put forth important recommendations on what more needed to be done.

Mr. Sheharyar Afridi (Federal Minister of Interior Government of Pakistan) in his speech he paid thanks to all stakeholders and Organizations for inviting him to the landmark conference while appreciating the initiatives about special education in KPK, he said that anything which is in the name of humanity must be applauded. He added that we should not use the word disable for Person with Disabilities instead, we should call them differently abled. As a volunteer, he ensured his support and commitment for taking the voice to the concerned departments and to make efforts for celebrating the international disability day across Pakistan. "For you, my office doors are always open and we will work as a team" he said, adding: "we are not here to survive we are here to compete all targets."

Session 1: Road to Inclusive Development ---- SDGs implementation in Pakistan --- how to participate, contribute and includes all.

Mr. Atif Sheikh Chaired this session. He invited Mr. Ghulam Nabi, who delivered his speech. He pointed that after 18th amendment we can see many changes in Pakistan about PWDs development. Ministries have been restructured making it difficult to recognize which organization is working on which issue. He appreciated that honorable guests gave some recommendations how SDGs will be implemented in Pakistan. He stressed that we should activate our provincial Ministry at Federal level. And we should make a system where provinces can have a direct link with each other's.



Mr. Shafiq_ur_Rehman President Milestones & Provincial Coordinator Punjab CBIB Network Pakistan delivered an impressive speech to the audience. He said that we still do not recognize the real issue. The real issue is division, contribution and opportunities sharing. Furthermore he added that Person with Disabilities do not need sympathy, it will not fulfill their requirements. They just have physical barriers and we want to overcome them. SDGs will never be achieved until we transfer needs to the concerned people. Everyone is dependent on one another, every person needs services so we cannot Label a community as disable.



He added, in development, we do not directly invest on Person with Disabilities. People can work for persons with disability but cannot work with them. First right of person with disability is mobility. If a normal person does not buy a car he have choice to walk but Person with Disabilities doesn't have choice. Sympathy is not Person with Disabilities need they just need to fulfill our rights. Disability movement is creating a new culture, a culture of acceptance for everybody.

Mr. Atif concluded Mr. Shafiq's speech in these beautiful words

“Human are creation of Allah, the amount of human beings can decrease but the formation of Allah cannot decrease.”

Mr. Khurshid President SADA Provincial Coordinator KPK & CBIB Network Pakistan from Malakand shared that in Malakand division they are going to inaugurate an Inclusive school in January. It will be the first institute in Malakand division which promote inclusive education. He added, they learned in US that disability is not a possession of an individual rather it is enrooted in our community structure which prevents human beings from work.



Dr. Lubna Hashmat Chief Executive CHIP Pakistan presented her research on facts and figures about disabled persons in Gilgit Bultistan. She found through data analysis that 75% disabled population didn't receive medical services, 93% didn't attend school and also depended on their families while 89% lived in isolation. She highlighted that this is an alarming situation regarding Gilgit Bultistan.



Mr. Imran Nazir President LCDDP in a short time conveyed a very important message. He said for inclusion, we have a key and it is economic empowerment. Until and unless a person does not engage in economic activities we are not able to ensure his social inclusion. He giving vent to his feelings emphasized on the need of Inclusion of persons with disabilities in the mainstream of life

Dr. M. Sarwat Mirza Chief Health and Research Executive HANDS presented presentation on 18 years of HANDS efforts for integrated development. In his research, he actually talked about HANDS failures and achievements and how they are able to achieve success in those failures.



Dr. Izhar Hashmi Director Programs Punjab Welfare Trust for Disabled Government of Punjab who chaired this session concluded the whole session with the words that the reason of our failure we have not submitted report yet. Firstly we need an authentic data then we will succeed in our goals. We'll not achieve any target unless we strengthen the CBID network.

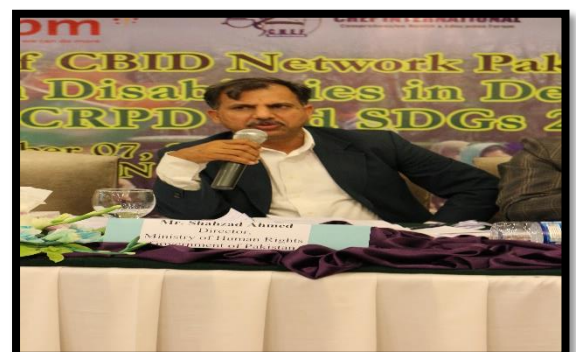


Session 2: Status of Legislation in Pakistan related to Persons with Disabilities (National & Provincial Perspective)

Mr. Shahzad Ahmed chaired this session and persons with disabilities from well reputed organizations joined as speakers.

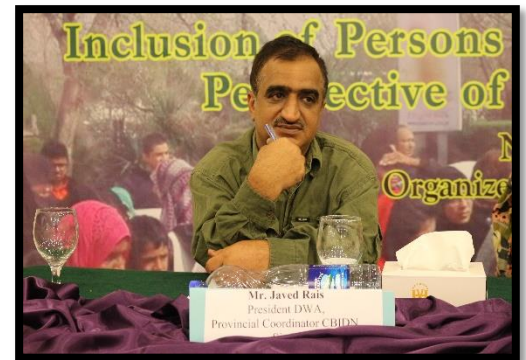
Mr. Javed Rais Provisional Coordinator CBID Network Sindh said that persons with disabilities rights bill has been passed in Sindh, it is not only passed but it is also implemented. Now in Sindh we have a department of persons with disabilities empowerment, which is “empowerment of persons with disability.” It took 15 years to achieve this target.

Ms. Zahida Qureshi President SSP & Deputy National Coordinator CBIDN Pakistan said the biggest problem is resources allocation. All regional disparities will end when resources will be allocated. Whenever people discuss disability issue, persons with disabilities are always looked down upon. Persons with disabilities do not have accessible washroom, wheel chairs or not even accessible houses. But they are skilled. They are working quietly but not in the home construction planning and not in the government planning. She concluded that we should make laws to protect persons with disabilities rights.

Mr. Atif Sheikh President STEP & Deputy International Coordinator CBID Network shared that 18 years ago, education and health were discussed whenever disability discussed in concerned departments of Pakistan. But now, in education, political participants, and infrastructures or even in every profession disability agenda has been discussed. And this discussion will be far away. We achieve this target because of those disabled leaders who are working in their areas. Through our struggle Persons with disabilities will get their rights and social protection.

Mr. Riaz Baloch President TSO and provincial coordinator CBID Network said that in Baluchistan they successfully passed bill of persons with disabilities rights. This is because of the support of all organizations. He added that we should stand for persons with disabilities rights.

Ms. Afshan Afridi Representative KPK came from Peshawar said the critical situation of Women with disabilities in all over Pakistan specially in KPK, most disabled women do not receive education. Education ratio is very low in KPK because disabled persons do not get education. However she was optimistic that the rights of disabled population will be ensured in near future. She pointed out a very important issue about disabled women that in KPK most of the families operate reproductive organs of



disabled women which cause cancer and ultimately, death. Although this is a criminal offence but no one is paying attention to it. Furthermore, she questioned as to why be there only sewing and embroidery professions for persons with disabilities, why not other professions? We need government support to resolve these issues, she said.

Ms. Komal Khan Representative Abbottabad said disabled group is unable to accept each other as well. Hearing people did not recognize the screaming of deaf people. And same situation with other disabled person. At first disabled persons need to accept each other then we will achieve our set goals. If we all stand together then we shall easily achieve all targets.



Mr. Shahzad Ahmed Director, Ministry of Human Rights Government of Pakistan concluded the session we make some laws for persons with disabilities. It is a time taking process let this law to be approved so that most of the issues may be resolved. He added, persons with disabilities address their concerns to the Ministry of Human Rights. Ministry of Human Rights will resolve your issues.

Mr. Muhammad Haider Imtiaz is a Legal advisor and Advocate in High Court. He gave his presentation on PowerPoint. He said that we are going to appeal in Supreme Court to give

Direction about the rights of persons with disabilities in various institutes to enforce persons with disabilities rights in their areas. Under the principal of UNCRDP, we have filed petition that institutes are accountable to the public about persons with disabilities duties.

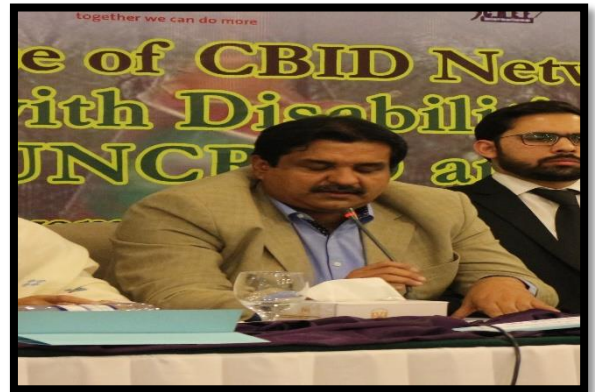
Mr. Malik Nawaz Disability Mainstream Manager Handicap International discussed on why data is important and what its importance is. He pointed out an important issue that in Pakistan we are not able to get the persons with disabilities data easily. And because of this, no one can work on persons with disabilities development.



Ms. Abia Akram CEO NFWWD briefly discussed importance of data on community based rehabilitation or inclusive development. She described role of women with disabilities in development sector, what their current situation is and how these women can overcome hurdles and barriers in their lives. She emphasized the importance, role and inclusion of women with disabilities in perspective of SDG's.



Mr. Rahim Marrie GM Disaster Management & SM HANDS Pakistan point out an issue that the persons with disabilities are not able to participate in development until persons with disabilities are counted. In the end he raises an important question about the contingency plans that are made for disasters, weather these plans are to be inclusive or not.



Ms. Azra Aziz Director, NIPS presented data on persons with disabilities facts and figures, education and health. Which is based on her research. She presented PowerPoint presentation. She told about the questioner prepared for person with disabilities to know about the exact data collection.

Ms. Munazza Gilani Country Representative Sight Savers Pakistan share some key messages about the data collection. She said that Sightsavers started a project for eye health with



Partner organization. She further add that in our planning for upcoming project we will trained the hospital staff how to deal with person with disabilities and make front desk or one window operation system. Globally, one billion people are included in PWDs category. She added that risk factor increase due to poverty. Disease factors, genetic factors, lack of awareness and lack of access to help, collectively these factors makes the situation vulnerable.

Mr. Habib Ullah Khan Member, Pakistan Bureau of Statistics Government of Pakistan briefly discussed census questionnaires and how are they collected data about persons with disabilities. He appreciated the collective work and effort of CBID Network to highlited the issue regarding census. He added that the SDG module indicators that are related to disability are already included in SDGs and PAK Bureau compete them through survey.



Dr. Khalid Maqbool Siddiqui Federal Minister for Information Technology and Telecommunication delivered his speech that People call you Persons with Disability but I would like to call you Person with Special Ability. In Ministry of Information Technology we have a program for persons with disabilities. We will also pay attention on your recommendations and try to meet them. Persons with disabilities will be able to work like an ordinary people.



Ms. Kishwar Zahra, Member of Parliament appreciated the serving of CBID Network for their contribution in inclusive development, she said that she had been engaged in many activities for persons with disabilities .She paid heartily thanks to persons with disabilities for their awareness raising for the parliamentarians and sensitization as well. She ensured that she on the behalf of her political party commits that they will be supporting this cause for the creation of barrier free and inclusive society for all.

At the end Ms. Saima Aslam Representative Saaya Association delivered declaration message with thanks to all organizations, organizers, stockholders for conducting a successful conference.

Declaration/ Resolution of the Conference


We, the leaders of Persons with disabilities, members of DPOs, national and international non-governmental organizations (NGO's) and people with disabilities from all over the Pakistan, have convened in Islamabad to develop a meaningful strategy for the full participation and equality of people with disabilities.

1. We recognize, with appreciation, that the last 5 years witnessed and increased awareness of issues faced by over 30 million people with disabilities in Pakistan, partially get voiced in Government and political circles as committed United Nations instruments or declarations.
2. We expressed deep concern, that such instruments and mandates have yet to create a significant impact on improving the lives of people with disabilities, especially women and girls with disabilities, who remain the most invisible and marginalized of all disadvantaged social groups.
3. We emphasize, that the continued exclusion of people with disabilities from the mainstream development process is a violation of fundamental rights and an indictment of humankind.
4. We share the conviction, that the full inclusion of people with disabilities in society requires our solidarity in working towards an international convention that legally binds nations, to reinforce the moral authority of the United Nations Standard Rules on the Equalization of Opportunities for Persons with Disabilities.

5. We believe, that the inception of the new government is an opportune time for people with diverse disabilities and their organizations, and other civic organizations, local and national governments, as well as the private sector, to collaborate closely in an inclusive and wide consultative process aimed at the development and adoption of an international convention to promote and protect the rights of people with disabilities, and enhance equal opportunities for participation in mainstream society.
6. We therefore urge, all heads of Federal and Provincial governments, Ministers, Parliamentarians, public administrators, local authorities, development partners and donors, persons with disabilities, civic organizations that participate in the development process, and socially responsible private sector organizations, to immediately initiate the process for legislation in Pakistan at Federal and Provincial levels and then its effective enforcement.
7. We further urge all participants in this process to actively facilitate the adoption of such a convention, which should address, inter alia, the following areas of priority concerns:
 - (a) Improvement of the overall quality of life of people with disabilities, and their elevation from deprivation, hardship and poverty.
 - (b) Education, training, remunerative work, and participation in decision- making process levels.
 - (c) Elimination of discriminatory attitudes and practices, as well as information, legal and infrastructure barriers.
 - (d) Increased allocations of resources to ensure the equal participation of people with disabilities.
 - (e) Consider inclusion in all development projects such as accessibility in infrastructure development projects
 - (f) Creation and provision of skills learning opportunities for income generation and independent living
8. We hereby, send out a call to action, to all concerned with equality and human dignity, to join together in widespread efforts embracing capitals, towns and cities, remote villages, and the National and Provincial forums, to ensure the adoption of an international convention on the rights of all people with disabilities, and
9. We commit our respective organizations to strive for a legally binding international convention on the rights of all people with disabilities to full participation and equality in society.
